- Legislative Update James handed out the possible list of topics for legislative action for 2018
 Legislative Session from Jason White. The KS BEMS will likely be either supportive or neutral on
 the listed topics. John Hultgren reported that KEMSA has its Strategic Planning session soon to
 determine what topics they will actively pursue. John also gave an update on legislation in the
 system and how those bills are progressing in Washington DC, primarily reimbursement issues.

If you have those, contact BEMS for instructions. Working on the medical director process. KSBEMS has been approved as a mobile test site by Pearson Vue. The site security procedures and cyber security must be the same as for a stand-alone, brick and mortar type test site. BEMS will be bringing in the computers for use at the test site.
